SUBJECT:Quality Management and Review System (QMARS) Release 3.12.1Announcement and HARP Account Registration Instructions

Quality Management and Review System (QMARS) version 3.12.1 will be released during the evening Monday, December 23, 2019, beginning at 9:00 p.m. ET. The system will be available to users again by 6:00 a.m. EST on Tuesday, December 24, 2019.

Effective December 24th, HCQIS Access Role and Profile (HARP) credentials will be required to access the QMARS application. To ensure timely access to QMARS, action needs to be taken by Contractors and CMS users. The attached HARP User Guide for QMARS also provides detailed instructions for QMARS access using HARP.

ACTION REQUIRED:

- Users who have an existing EIDM ID and an existing QMARS user role:
 - 1. Your EIDM ID has now become your HARP ID. Your HARP account is set up and you will proceed with the steps below:
 - 2. Access the QMARS application at <u>https://qmars.hcqis.org</u>
 - Use your existing EIDM ID and EIDM password as the Username and Password for login.
 - You will then be guided to add multifactor authentication methods.
 - Once you have completed that process, you can log into QMARS.
 - If needed, you can update your account with your contact information and add or remove devices for multifactor authentication at https://harp.qualitynet.org.

• <u>New QMARS users who do not have an existing EIDM ID or HARP Account:</u>

- 1. Access the QMARS application at <u>https://qmars.hcqis.org</u>
- Register for a HARP account by selecting the <u>Sign-Up</u> button on the QMARS homepage. Details for this process are outlined in the attached document: HARP User Guide for QMARS
 - a. Important: Do not use special characters when creating your HARP username. Also, do not use your email address as your username. (Note: special characters can be used in your password, but not in your username).
- 3. Once you have a HARP account, provide your HARP ID to the QMARS Admin for your organization, asking that they set up your user role in QMARS. The process for provisioning users in QMARS has not changed.

(Note: CMS and auxiliary users should continue to use the same process to submit their role requests as they have up to this point)

4. Once you have been provisioned in QMARS, you will be able to log in. At your first log in, you will need to set up your multifactor authentication.
