Important News & Announcements

The following PRS 2.0 enhancements were released to Production in June:

- **HSP Module**
 - Added *TIN* (Tax Identification Number) to the Advanced Search, Search Results, and Details pages.
 - **API Updates**
 - Released a new endpoint (`getChanges`) for the HSP Module. This endpoint will accept a timestamp and returns all Providers that have been modified since that timestamp. More details can be found in our [Swagger documentation](#).
 - **CDR Data**
 - The HSP Module data was published to the CDR on June 11th. Any interested organizations can begin working with the CDR team to request access.
