PRS 2.0 Development and Design Update #8

HSP expanded edit capability

This message provides updates for the PRS 2.0 HSP module that will provide ADOs with expanded edit functionality for PRS 2.0 records. It also contains the PRS 2.0 reference materials for User Role process, data sources, and an updated simplified Roadmap original included from the original Development and Design Update communications sent between 12/2022 and 5/2023.

What changed from communication #7 to #8?

The release for HSP extended edits has been moved from 6/27 to 7/18 due to an emergency • project the team is handling.

What are the HSP module expanded edits in PRS 2.0?

- HSP module expanded edits in PRS 2.0 will include ability to add/edit to the following: HSP Details (including add/edit new CCNs/Providers)
 - 0
 - **Physical Location** 0
 - **Cross Reference** 0
 - Unit bed 0

• The PRS 2.0 APIs that were exposed for connection (on 2/7) will be updated after 7/18 to reflect the expanded edits changes as well – further communications for Prod timing will be sent later.

What will NOT be a part of HSP module expanded edits release in PRS 2.0?

- ASC and IPF file upload processes <u>will not</u> be a part of the HSP expanded edits release.
- HSP module expanded edits in PRS 2.0 <u>will not</u> include the ability to add/edit the following.
 - QIO defined fields.
 - FI/Carrier/MAC

With these new expanded edits, does this mean PRS 2.0 will be the definitive source of truth for this data now and not iQIES in the HSP Module?

- iQIES will remain the source of truth for the data present in PRS 2.0 HSP Module.
- The expanded edits create an opportunity for users to add/edit HSP details for the above referenced fields and create CCNs/Providers directly in PRS 2.0.
- As the source of truth for this data (iQIES) cannot be changed, PRS 2.0 will identify the additions and edits made within PRS 2.0 as "community updated records", which are considered "unverified" to the source of truth data.
- The reasoning for this is because there is no approval to push the PRS 2.0 data back to the source (iQIES) for reconciliation.
- The user community will be able to toggle between the iQIES data source of truth and fields edited directly in PRS 2.0 will be visually identified as "community" edits.

When will the HSP module expanded edits be available in PRS 2.0?

• HSP module extended edits will be available in PRS 2.0 after 7/18.

Will I need to request a new PRS 2.0 role through HARP once the HSP expanded edits are ready?

• No – if you presently have a BFCC Editor or HSAG Editor role in PRS 2.0 now, these roles will be pre-configured to provide the HSP expanded edits capabilities upon release to Production.

<u>Until the new HSP expanded edits are complete, what does this mean for PRS 2.0 in the meantime?</u>

- As previously noted in PRS Communications, if any Provider and Contact Information data was updated within PRS 1.0 HSP module from January 11, 2023 that data <u>will not</u> be in PRS 2.0.
- Users should continue to add/update CCNs and use the Vendor Contract and Waiver sections within PRS 1.0.
- The HQR Team owns and maintains the PRS 1.0 Vendor Contract and Waiver sections and will identify a schedule to move those modules to their NextGen system within 2023.

I don't have a PRS 2.0 role yet – how do I request one?

- If you are new to PRS 2.0 and would like to access the system, please log into <u>HARP</u> and navigate to User Roles; select Request a Role in HARP; on the *Select a Program* page, select QualityNet Workspace; on the *Select an Organization* page; select ESS PRS; Under *Roles*, select (as applicable) PRS General User, BFCC Editor, or HSAG Editor and Submit.
- Once the role is approved you can login to <u>PRS 2.0 within the QualityNet Workspace</u>.
