**Physician Module & Physician Member Module:** Both modules were released to production on December 19, 2023. The Physician Member module is included within the Physician Module under the “Group Practice Membership” section.

**Physician Group Module:** This module is currently being developed with a planned release in the first quarter of this year. More details, including the release date, will be provided as we get closer to completing development.
