FEBRUARY 2023 HIGHLIGHTS

Looking ahead to April 2023, we will expand the collaborative experience by partnering transplant QI Teams and donor QI Teams monthly to larger groups. We will also reduce the number of ETCLC case study calls each month from two to one. Additionally, we will begin to narrow the scope of initiatives being reported by organizations.

The CMS/HRSA Kidney Donation & Transplant Initiative While the collaborative offers autonomy to the QI Coach(es) and their Teams, since April of 2022, we have witnessed a clear convergance of activities and inititiaves with members identifying and working on the most effective activities to drive the National Aims: increase kidney transplants, reduce unused organs and improve utilization of high-KDPI kidneys throughout the country.

Following discussion with the QI Coaches, the National Faculty and evaluation of the data reported in the Progress Tracker by collaborative members, we have begun to narrow the promising practices for Donor Hospitals, just as we did for Transplant Centers in October. Similar to the "Top 11" Aim 2 Focused Effort, TAQIL will release the top activities identified by participating Donor Hospitals, as well as, a listing of the OPO promising practices from our first year in our March 2023 Change Package Revision.

Barriers & Successes from Our 25 Quality Improvement Teams

In February, QI Teams continued to work together to promote meaningful improvement of their procurement, donation, and transplant processes. The following figure provides an overview of collaborative initiatives in action:

Challenge	Solution		
Honoring First Person Authorization (FPA) and family approach timing	A team discussed the use of VOALTE, a secure medical communication app, to improve communication between ICU physicians and the OPO and to support the families in the process.		
Organ Offer Filter hesitancy "What if we miss the right organ for one of our patients?"	Refer to the new Organ Acceptance Rate (OAR) metric that can provide meaningful incentive to organizations that are hesitant to implement offer filters.		
Inconsistent Decision-Making and Acceptance Practices	In addition to education, a collaborative member created a script for coordinators regarding COVID+ donors. They also analyze comparative data, organ acceptance data, and turn downs. So far, they have done 7 transplants with COVID+ donors, both symptomatic and asymptomatic organs.		
Greater attention to Waitlist Management practices	Monthly waitlist work sessions are done with the pre-coordinator team, nephrology team, and surgeons. The Transplant Center developed a "hot list" of patients with defined listing criteria and instituted a DGF clinic to manage patients. The dedicated clinic also helps with dialysis coordination, which has shown a significant shift to increase the number of active patients on their waitlist.		
More Timely Referrals due to improved processes	The new initiative involves daily, in-person, contact outside of the previous 10am-10pm calls. They are hopeful this will allow for more timely discussions and for the team to be ready when the patient is pronounced brain dead. These timely discussions have already allowed for greater success in converting unregistered donors.		

A very special thank you to QI Teams T10W, D14E, D17E and T11 for their presentations during our February Case Study and Pacing Event sessions. Sharing of current activities provide valuable resources and generate new idea among collaborative colleagues.

Who is involved in the ETCLC? During the Fall of 2021, the ESRD Treatment Choices Learning Collaborative enrolled more than 80% of US transplant centers, 90% of Organ Procurement Organizations (OPOs), plus the donor hospitals in each OPO's donor service area. Together, these groups represent more than 400 organizations, working in 25 separate Quality Improvement (QI) Donation and Transplant Teams, including one Pediatric Team. Professional organizations and patient advocacy groups are organized into the Leadership Coordinating Council (LCC), while the National Faculty provides oversight on the work to enhance the ETCLC Kidney Donation and Kidney Utilization Change Packages.

<u>What is the difference between an ETCLC Case Study and a Pacing Event?</u> Pacing Events offer a Best Practice, Process, or Procedure and are available bi-weekly. A Case Study refers to a specific Clinical Case or Barrier Discussion and is offered twice monthly. (Learning Sessions are available most Wednesdays throughout the Year and led by QI Teams.)

Did You Know: Your <u>Slack</u> account will deactivate if you do not log in regularly.

Please log into Slack at least once per month to stay current with ETCLC discussion taking place in the collaborative.
