

### **MARCH 2023 HIGHLIGHTS**

As the community prepares for the national spotlight of *Donate Life Month*, QI Coaches and Co-Coaches are working together to align and expand their QI Team calls in April. These larger donor and transplant-

focused QI Teams will merge to expand the depth of knowledge of each combined team to spread promising practices, begin to narrow the scope of initiatives, and continue to work toward national initiatives in the coming prting on Change Package and quality



months. The collaborative began a year ago with a broad request for reporting on Change Package and quality improvement initiatives. This yielded more than 370 individual projects in the first year of the collaborative. These topics converged into a dozen core areas which will guide the work of collaborative over the next year.

We applaud the incredible efforts taking place within each organization to improve transplant and donation and we thank all those participants that report on the progress of their inititatives. During this time, a clear convergance of efforts in less than a dozen core areas have been identified and will now guide the collaborative over the next year. Finally, the updated release to the Change Packages will be available to the community in late-April. The revisions to the Change Packages includes insights and experiences from the first year of the collaborative; it will be the first in a a series of annual updates since their original release in March 2020.

The forthcoming additional details will include insight into methods, staff involvement, costs, data collection and the type of resources that might be necessary to replicate these efforts. We will also surface effective practices for integrating sustainable initiatives into organizations. Once these details are confirmed, additional organizations will be able to implement these model initiatives in order to achieve their own success in driving change and meeting the three National Aims.

### ETCLC NATIONAL AIMS | 2022 - 2023

The ETCLC identifies highly effective practices currently in use to spread throughout the organ donation and recovery, kidney care, and kidney transplant community to achieve the following three Aims:

All counts and rates are based on a 12-month lookback ending in last month of available data. Projections, based on predictions from LOESS regression models, are compared to targets to determine status by the end of August 2023.

### ETCLC Patient & Donor Family Representative (PFR) Spotlight

The PFR group met in March to discuss "What I Wish I Would Have Known." Patient and Donor Family perspectives vary from starting or restarting dialysis, experiencing the transplant process from referral to post-op, and those that made the decision to donate their loved one's gift to save another on the most difficult days of their lives. These lived experiences remind all of us why we are part of the transplant and donation community. Their feedback is being compiled to share in the ETCLC and help guide our efforts to better prepare the families and patients we serve during challenging life transitions. ### Insights from our 25 Quality Improvement Teams

This month, conversations in the community touched on emergence of shifts in mindset, specifically our language and terminology.

Current Terminology	Consider This Instead
Triggers	Soft Cues
Withdraw Care	Goals of Care or Expanding Care for the Possibility of Donation
Marginal Kidney	Better Than Dialysis or Less Than Perfect

Additionally, the following figure provides insights into some of the hot topics and emerging themes from collaborative discussions during the monthly QI Team calls:

Challenge	Solution		
Shift in Mindset	Multiple organizations mentioned that the ETCLC has led them to be more aggressive in organ procurement and change their perspective regarding the utility of a less-than-ideal / better than dialysis (BTD) kidney. The new thinking is that BTD kidney's "might change a person's life for a few years" and get them off dialysis.		
Patient Accountability in Transplant Process	Several organizations discussed the patient's degree of agency in the listing process. To support patients in their decision making, organizations are conducting initiatives to help promote testing readiness, regular communication between patients and the transplant program, increasing education, and generally more self-efficacy among patients in need of transplant.		
Progress Tracker Utilization	Building off the Progress Tracker demonstrations during QI Team meetings in February, teams are discussing how the Progress Tracker facilitates collaboration. One individual shared that, prior to attending a recent in-person conference, he references the Progress Tracker to learn about the initiatives that other ETCLC participants are working on. He finds this helps facilitate productive discussion during QI Team calls as well.		
Access to Outside Records	In multiple instances, organizations report inadequacies in access to patient medical records to verify testing conducted outside of their organization. This problem contributes to duplicative efforts and inefficiency in the listing process.		
Use of Data Reporting Tools	Multiple organizations report gaining value from the RUM Report to assist with decision-making regarding procurement and utilization. OPOs indicate that sharing the OUT Report with transplant centers can help them understand their usage patterns.		
Nuances of the Pediatric Experience	The pediatric team faces unique challenges and opportunities. While pediatric organizations discussed their difficulties facilitating the transition to the adult waitlist for their adolescent patients, one organization reported success in holding a clinic that promoted vaccinations for those needing to be or remain waitlisted.		
Pumping	Organizations are reporting increased utilization of pumping, and transplant centers generally indicate that all else being equal, a pumped organ is preferable. However, organizations are still working out the details around the interpretation of pump numbers, transportation, and the return of physical pumps.
