# PRS 2.0 Development and Design November 2023 Update

This message provides current and/or planned updates for the **PRS 2.0 system development.** It also contains the PRS 2.0 reference materials for User Role process, data source overview, and the release timeline.

#### **Important News & Announcements**

**System-to-System Authentication is now available!** This feature allows ADOs to connect their system(s) directly with PRS 2.0 using a service token, eliminating the need for user roles. Once connected, your integrated system will have full access to all PRS 2.0 APIs and will be able to pull any PRS 2.0 data needed directly into your system. Detailed onboarding instructions were provided in the *Development and Design #12* communication sent on October 16<sup>th</sup>. If you need any help or have questions, please reach out to us on Slack at **#help-prs2**.

**Physician Module:** We are finishing up testing for this module and are targeting to have it live in PRS 2.0 before December 15th. More details will be provided as we get closer to the release, including when the PRS 1.0 version of that module will be decommissioned to coincide with this release.

**Physician Member Module**: This module will be rolled into the Physician Module and will be part of the release in early December. The Group NPI will be displayed but will not link to the Physician Group Details until that module is released in early 2024.

applicable) **PRS General User, BFCC Editor, or HSAG Editor** and **Submit.** Once the role is approved you can login to PRS 2.0 within the QualityNet Workspace.
