### **Upcoming Communications Call**

Please join us for a Communications Call this Thursday, January 21<sup>st</sup>, at 1:00pm EST. During this upcoming call, the Data & Analytics team will reveal a newly developed request form for the user community and will review important SAS Viya/CDR best practices. #### **HQR PRS Data Issue – Update**

On 1/10/2021, a data discrepancy was identified in the HQR PRS database that impacted the resource\_hqr\_prs.hlth\_serv\_provider table within the CDR. The issue caused some facilities to show up incorrectly as closed. Data extracted from this table during the past 30 days may be affected. The issue has been resolved in the CDR as of the 1/18/2021 data refresh. If you have any questions, please contact us at HCQIS\_Data@hcqis.org.

#### **QMARS Data Issues – Update**

On 12/16/2020, an issue was reported with QMARS data where updates were no longer occurring in the source QMARS schema. Data updates stopped occurring for many tables between September to December 2020. The QMARS ADO has worked to resolve this issue in most of the tables. On 1/12/2021, updated data was made available in the CDR. There are some tables that are still impacted by the issue; however, the QMARS ADO is working to resolve the remaining tables. Please reference the DAMOD Known Issues Log for the list of impacted tables.

A separate issue remains for text fields in the QMARS data that are being truncated in the source schema. This issue is universal for columns with a string data type that are greater than 32 characters long. The QMARS ADO is working to resolve this issue and the DAMOD team will refresh with corrected data when it is available.

More information will be posted to the DAMOD Known Issues Log and CDR Data Catalog when it is available.

#### **NHSN HAI Files for Hospital Quality Reporting (HQR)**

The Hospital Quality Reporting (HQR) external file submission tool will begin to deliver external NHSN files submitted from the application into the SAS Viya workbench for organizations with approved DUAs. Under an organization's SAS Viya workbench, the "external-data>nhsn" directory will contain these files from the HQR application. The application will immediately copy the files to the folder upon submission and the files can then be read into SAS datasets and/or project databases in Hive. The delivery date of these files will be tied to the monthly submissions and will be incrementally available during the submission window. The delivery date and availability of these files will be more frequent as the quarterly deadline approaches. Additional information will be added to the Data Catalog.

#### **CDR Weekly Refresh Update**
