## **CSAT Update**

On 1/27/2021, a discrepancy was reported in the CSAT Part D *quantity\_dispensed* field. Some records are incorrectly showing *quantity\_dispensed* = '0' for September 2016 to June 2017. This issue does not impact the DDPS Part D source data. The issue is now targeted to be resolved by 2/15/2021.

An additional issue has been reported impacting state code assignments for beneficiary state codes and provider state codes greater than '53'. This issue impacts Part A, Part B, and Part D files. Claims for the beneficiary and provider state numbers above '53' are not being assigned a state code to be included in CSAT. This issue is now targeted to be resolved on 2/8/2021 for CSAT\_2 and CSAT\_5 files from 11/2018 to current. It is now targeted to be resolved on 2/15/2021 for CSAT\_2 and CSAT\_5 files from 9/2016-10/2018.
