Hospital Quality Reporting (HQR) Sources – Available in CDR

The Data and Analytics Modernization team has granted access to the following HQR Hive schemas for organizations with approved access according to their CMS Data Use Agreement (DUA).

- quality_measures_hqr_char_abst
- quality_measures_hqr_ecqm
- quality_measures_hqr_val
- provider_hqr_nop
- resource_hqr_sec_admin

The HQR ADO is planning to provide supporting documentation for new sources incrementally over the next few months. Data dictionaries and data models will be posted to the CDR Data Catalog as they are available. Refresh dates for each source are posted to the CDR Data Catalog. EQRS Redshift Data Issue

The EQRS ADO reported an issue with the production EQRS Redshift Cluster that impacted 25 of the 63 tables in the "Org" schema. This impacted SAS Viya users connecting directly to EQRS Redshift. No columns were affected; however, all rows in the affected tables were duplicated (or more). The issue started around 3/20/21 and was resolved as of 3/23/21. Any users extracting data around that timeframe from tables in the "Org" schema may be impacted. Further details have been added to the Known Issues Log.

Hive Intermittent Issue - Update

As communicated previously, some CDR/Hive users have experienced intermittent issues with jobs when reading from SAS and writing to CDR/Hive. Over the weekend, the Data & Analytics Modernization team identified a possible cause of the Hive intermittent issue and integrated a fix. The team is currently monitoring the environment to see if the integrated fix has resolved the issue. For users who were experiencing this issue in the past, please resubmit your jobs. If you are still experiencing issues after resubmitting your jobs, please submit a help desk ticket by emailing servicecentersos@cms.hhs.gov, asking that it be routed to ADO-CDR-Support.
