Zeppelin Rollout Update – Group 1 Onboarding Begins Tomorrow!



The Data & Analytics Modernization Team will begin phased onboarding **tomorrow** for the new CCSQ Application Platform (CAP) tool, Zeppelin. Zeppelin will be offered alongside SAS Viya to organizations working with the Centralized Data Repository (CDR). *Please note that Zeppelin is not replacing SAS Viya, as Zeppelin will be an additional tool within the CCSQ*

Data & Analytics environment and part of the CCSQ vision to increase the number of collaboration tools for utilization.

The first group of organizations will begin onboarding on Tuesday, May 25th. On Tuesday, June 1st, the second group of organizations will be notified to begin onboarding. The organizations within these groups submitted requests via the CCSQ Data & Analytics Request Form on Confluence and were selected based upon the priorities that the teams provided in their requests.

Please note that once all initial organizations are successfully onboarded and working in the Production environment, the DAMOD Team plans to provide all QualityNet Analytics organizations the ability to onboard into Zeppelin on June 8th. These other interested organizations would not need to fill out the request form on Confluence, as HARP roles will be available for them on that date to request. *If an organization is not interested in utilizing Zeppelin, no action is needed.*
