New CAP Tool Zeppelin - Request Access!

As of June 8<sup>th</sup>, all QualityNet Analytics organizations can request access to the newly added CAP tool, Zeppelin. Please note that iQIES organizations were identified to not need the Zeppelin application for their analytic work. Due to this, onboarding will be provided to organizations only underneath the QualityNet Analytics HARP program at this time.

Please note that Zeppelin has been offered alongside SAS Viya to organizations working with the Centralized Data Repository (CDR). *Zeppelin is not replacing SAS Viya, as Zeppelin will be an additional tool within the CCSQ Data & Analytics environment and part of the CCSQ vision to increase the number of collaboration tools for utilization.*

#### **HHA Claims Regulation Change**

The Data & Analytics Modernization Team received a recent user question regarding HHA claims with the 'fi\_clm\_proc\_dt' prior to the 'clm\_thru\_dt'. This nuance is not a data error but instead a result of a recent change in HHA payment regulations. Payment regulations changed home health 'Requests for Anticipated Payment' (RAPs) to be no-pay submissions instead. As part of that change, submission of two 30-day RAPs (a current and a future) for each 60-day HH certification period is also allowed. This change was implemented as part of a Medicare change request (CR) stating:

"11855.3 The contractor shall allow the claim from date, claim through date and any line-item date to be a future date if the Type of Bill is 0322 and the from date is on or after January 1, 2021."

RAPs existed previously in NCH claims data however this policy change simply allows them to be processed earlier. DAMOD wanted to ensure the claims user community is aware that if they see this case in the HHA claims going forward, it is **not** a result of a data or claims processing issue.

RAPs do get a Final Action designation of 'true' until the true claim is submitted, replacing the RAP. If you do not want to include any RAPs in your analysis, you can filter them out easily by adding a condition **excluding** HHA records where:

- 'clm\_from\_dt' = 'clm\_thru\_dt'
- 'clm tot chrg amt' = 0.

If you want to exclude only future RAPs, add a condition to **exclude**:

• fi\_clm\_proc\_dt < clm\_thru\_dt

#### **CDR Data Issues Updates**

The below list includes updates on current data issues within the Centralized Data Repository (CDR). Please monitor the CDR Known Issues Log for the latest statuses and targeted resolution dates.

Schema Name	Current Status
beneficiary_data	There is currently an open issue with Beneficiary Information on the Cloud (BIC) where MBIs overlap among multiple beneficiary keys for 63 cases. This affects the beneficiary_data schema in the CDR. BIC is currently working to correct this issue and will notify DAMOD when a target resolution date is available. Once the corrected data is available, the DAMOD team will refresh the data in the CDR.
csat_2, csat_5 (Part B)	An issue in processing and guidance on Part B claims data [CARRIER only] recently occurred that impacted CSAT data.  Updates to the CSAT code were made as part of the 6/2/2021 refresh. Two new columns (nch_smgt_link_num and clm_sgmt_num) were added to the BBASE tables. CMS has approved a rerun of the impacted CSAT Part B data to correct historically impacted files and a date for availability will be provided as soon as possible.
csat_2, csat_5 (Part B)	The Part B Final Action logic in the CSAT code is not processing in the correct order to meet the requirement for a static data set with 2-month and 5-

	month maturity. CMS has approved a re-run of the impacted CSAT Part B data to correct historically impacted files and a date for availability will be provided as soon as possible.
csat_2, csat_5 (Part D)	The Part D re-run is currently in-progress and
	targeted to complete by 6/25/2021. Rerun will
	include CY 2018, 2019, 2020 and January 2021.
beneficiary_data	The data owner has confirmed that the missing MBI issue persists after their 4/26/2021 fix. They are working to evaluate the scope of the missing MBIs and determine a plan for correction. The examples provided by the DAMOD team are under review with their SMEs.
qmars	Longer text fields in the QMARS data are currently being truncated in the source schema. This issue is universal for columns with a string data type that are greater than 32 characters long. No target date for resolution has been provided by the QMARS ADO.
