assessment_iqies	An issue occurred during the assessment_iqies refresh of the table 'hha_asmt_fed' on 11/5/2021. The table was successfully refreshed on 11/9/2021.
resource_hqr_prs_ supplemental	The Beneficiary merge code for PRS was found to have an issue where it isn't updating existing records and new data isn't being loaded properly into PRS. This was identified with death data originally sourced from BIC.  The following tables are impacted:

	The HQR ADO is working to correct this merge code and pull anything that was missed since Nov 2020.
qmars	There is an issue with QMARS data where the count of appeals in the CDR differs from the QMARS system. The QMARS ADO is

	working to investigate the issue and determine a resolution. Once the QMARS ADO corrects the data issue, the DAMOD team will pull the corrected data into the CDR.
qmars	Longer text fields in the QMARS data are currently being truncated in the source schema. This issue is universal for columns with a string data type that are greater than 32 characters long. No target date for resolution has been provided by the QMARS ADO.
